I. Introduction

1. The Registry hereby informs the Trial Chamber that Ms Jennifer Naouri (“Ms Naouri”), a lawyer who satisfies the criteria of rule 22 of the Rules of Procedure and Evidence (“RPE”) and regulation 67(1) of the Regulations of the Court (“RoC”) to be Associate Counsel, has been appointed as Associate Counsel for Mr Laurent Gbagbo (“Mr Gbagbo”) on 1 August 2018.

III. Applicable Law

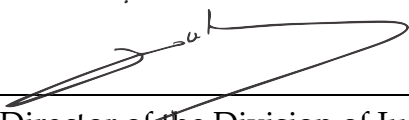
3. This submission is made on the basis of articles 43 and 67(1)(d) of the Rome Statute, rules 20 to 22 of the RPE, regulation 67 of the RoC, regulation 123(1) of the Regulations of the Registry and articles 5, 7(4) and 22(3) of the Code of Professional Conduct for counsel (“Code”).

IV. Submissions
