Introduction

1. On 25 July 2018, Pre-Trial Chamber II received the "Prosecution's request to reclassify its submissions and to make available a public record for the purposes of the hearing scheduled before the Appeals Chamber".¹
2. On 1 August 2018, Pre-Trial Chamber II issued a "Decision Regarding Reclassification of Documents",² in which it requested Jordan to indicate whether certain documents referred to in paragraph 6 of the Decision can be made public without redactions or, if deemed necessary, to re-file those documents with redactions.³

3. Jordan wishes to inform Pre-Trial Chamber II that, in its view, the documents referred to in paragraph 6 of the Decision can be made public without redactions.
