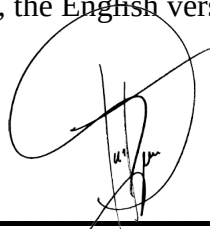
Pursuant to regulation 23*bis*(3) of the Regulations of the Court,
