1. By this submission, the Prosecution respectfully notifies Trial Chamber X of its filing before Pre-Trial Chamber I the “Prosecution Request for corrections and amendments concerning the Confirmation Decision” (“Amendment Request”).
2. The Prosecution already foreshadowed to Trial Chamber X that it would be filing an application regarding amending the charges earlier confirmed by Pre-Trial Chamber I.¹
3. In the Amendment Request, the Prosecution applies for authorisation from Pre-Trial Chamber I to correct and amend the charges, as detailed in its application, and further seeks for Pre-Trial Chamber I to decide on the Amendment Request expeditiously in light of the scheduled trial date in this case. As explained further in the Amendment Request, the corrections and amendments sought do not constitute additional or more serious charges and therefore no further oral confirmation hearing is needed.
4. The Prosecution submitted the Amendment Request on 30 January 2020 before Pre-Trial Chamber I, and issues this notification to Trial Chamber X accordingly.
