Other

Background

1. On 23 May 2019, the Defence for Mr. Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud (the Defence) submitted its “Addendum to “Corrigendum Defence Observations on Registry Report ICC-01/12-01/18-307-Conf-Exp and Prosecution Response ICC-01/12-01/18-318-Conf-Exp, and Request for Variation” ICC-01/12-01/18-343-Conf-Exp-Corr”.¹
2. On 18 February 2020, during the status conference, the Single Judge of Trial Chamber X instructed the Registry to file in the record of the case, by 26 February, a list of *ex parte* filings for which no version is available to the Prosecution and/or Defence. The Single Judge also instructed the parties to review their filings, by 18 March 2020 at the latest, with a view to providing redacted versions to the other party or requesting reclassification.
3. On 02 March 2020, the Registry filed the “Transmission of the List of *ex parte* Filings filed in the Record of the Case”.²
4. On 03 March 2020, the Registry filed a “Corrected version of the Annex to the Transmission of the list of Ex Parte filings filed in the Record of the Case”.³
5. On 06 March 2020, the Registry filed its “Addendum to ICC-01/12-01/18-621-Conf-Anx-Corr”.⁴
6. The Defence has classified its request as confidential *ex parte* only available to the Defence.

Submissions

7. In light of the above and in compliance with the Single Judge’s instructions, the Defence respectfully requests the Single Judge of Trial Chamber X to order the reclassification of filing ICC-01/12-01/18-352-Conf-Exp as public; and further requests that the classification of ICC-01/12-01/18-352-Conf-Exp-Anx as *ex parte* (Defence only) be maintained, due to the fact that it concerns Mr. Al Hassan’s Medical file.
