I. Introduction

1. The Registry hereby transmits to Pre-Trial Chamber I (“the Chamber”) in accordance with Rule 13 (1) of the Rule of Procedure and Evidence, a document received from Judge Fouad Baker, as instructed by the Chamber’s Senior Legal Officer (“the Senior Legal Officer”) on 27 March 2020.¹

II. Procedural History

2. On 20 February 2020, the Chamber issued its “Decision on Application for Leave to File Observations Pursuant to Rule 103 of the Rules of Procedure and Evidence”.²
3. On 27 March 2020, the Court Management Section (“CMS”) received an e-mail from Judge Fouad Baker requesting the Registry to file a document (“Annex”) before the Chamber.³
4. The same day, CMS contacted the Chamber requesting its guidance on how to register the document.
5. At 17:25, the Senior Legal Officer instructed CMS to submit the document via a Registry transmission filing.⁴

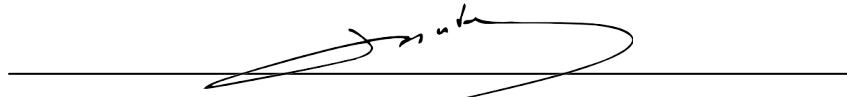
