Decision on the Temporary Designation of a Single Judge

PRE-TRIAL CHAMBER I of the International Criminal Court ("the Chamber" and "the Court", respectively);

NOTING the "Decision Assigning the Situation in Darfur, Sudan to Pre-Trial Chamber I" issued by the Presidency on the 21 April 2005¹;

NOTING the "Decision on the Designation of a Single Judge" issued by the Chamber on 10 May 2007 designating Judge Akua Kuenyehia as single judge of Pre-Trial Chamber I for the case *The Prosecutor v. Ahmad Muhammad Harun* ("Ahmad Harun") and *Ali Muhammad Ali Abd-Al-Rahman* ("Ali Kushayb") ("*The Prosecutor v. Harun and Kushayb*") in the Situation in Darfur, Sudan from 10 May 2007 until otherwise decided by the Chamber;

NOTING the "Decision replacing a judge in Pre-Trial Chamber I" ² issued by the Presidency on 22 June 2007;

NOTING article 39 (2) (b) (iii) of the Rome Statute ("the Statute"), pursuant to which the functions of the Pre-Trial Chamber shall be carried out either by three judges of the Pre-Trial Division or by a single judge in accordance with the Statute and the Rules of Procedure and Evidence;

NOTING article 57 (2) (b) of the Statute, pursuant to which a single judge of the Pre-Trial Chamber may exercise the functions provided for in this Statute, unless otherwise provided for in the Rules of Procedure and Evidence or by a majority of the Pre-Trial Chamber;

NOTING rule 7 (1) of the Rules of Procedure and Evidence and regulation 47 (1) of the Regulations of the Court, pursuant to which the designation of a single judge shall be based on criteria agreed upon by the Pre-Trial Chamber, including seniority of age and criminal trial experience;

CONSIDERING that at this stage of the proceedings in the case *The Prosecutor v. Harun and Kushayb* in the Situation in Darfur, Sudan the designation of a single judge will ensure the proper and efficient functioning of the Chamber;

FOR THESE REASONS,

DECIDES to designate Judge Anita Ušacka as single judge of Pre-Trial Chamber I for the case *The Prosecutor v. Harun and Kushayb* in the Situation in Darfur, Sudan from 18 August 2007 until 16 September 2007, inclusively;

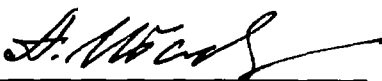

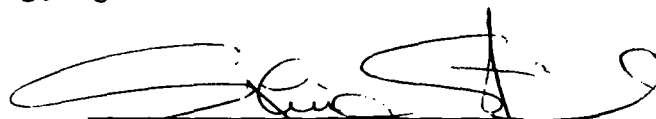
