1. The Defence for Mr Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud (*the Defence*) hereby submits its communication of the second and third metadata update package.
2. On 06 July 2020, the Defence disclosed to the Prosecution the contents of the “Pre-Trial Metadata Update D28 package 02 06 July 2020”. Package 02 concerns fourteen (14) documents, as reflected in Confidential Annex A.<sup>1</sup> Due to technical issues, Package 02 was not uploaded correctly onto ringtail. Therefore, on 17 July 2020, the Defence re-disclosed the metadata in Package 02 to the Prosecution via “Trial Metadata Update D28 package 03 17 July 2020”.
3. Package 03 17 July 2020 concerns thirty-four (34) documents. As reflected in Confidential Annex B,<sup>2</sup> and as noted above, this Package 03 is a reissue of the metadata update contained in Package 02 and further contains an update of the metadata of other evidentiary materials previously disclosed by the Defence.
