The Presidency of the International Criminal Court (the ‘Court’);

NOTING the memorandum of 9 September 2020 from the Prosecutor addressed to the Presidency, in accordance with regulation 45 of the Regulations of the Court (the ‘Regulations’), notifying the Presidency that on 4 September 2020 she received a referral in accordance with article 14(1) of the Rome Statute from the Government of the Plurinational State of Bolivia;¹

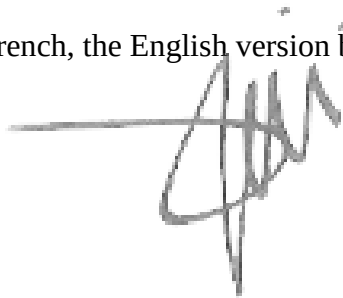
NOTING regulation 46(2) of the Regulations, pursuant to which the Presidency shall assign a situation to a Pre-Trial Chamber as soon as the Prosecutor has informed the Presidency in accordance with regulation 45 of the Regulations;

NOTING the ‘Decision assigning judges to divisions and recomposing Chambers’ of 16 March 2018,² and that on 25 June 2019 the Presidency constituted Pre-Trial Chamber III;³

NOTING the current workload of Chambers in the Pre-Trial and Trial Divisions, as well as the individual workload of judges;

HEREBY DECIDES to assign the situation in the Plurinational State of Bolivia to Pre-Trial Chamber III with immediate effect.
