PRE-TRIAL CHAMBER II (the ‘Chamber’) of the International Criminal Court (the ‘Court’) issues this Decision on the designation of a Single Judge.

1. On 30 May 2014, the Government of the Central African Republic (the ‘CAR’) referred the situation in the CAR since 1 August 2012 to the Court.¹
2. On 16 March 2021, the Presidency of the Court recomposed the Chambers and assigned the following situations and cases therein to the Chambers: Central African Republic I; Central African Republic II; Republic of Uganda; Darfur, Republic of the Sudan; Republic of Kenya; Republic of Côte d’Ivoire; Islamic Republic of Afghanistan; and Republic of Burundi.²
3. On the same day, Judge Rosario Salvatore Aitala was elected as the Presiding Judge of the Chamber.³
4. The Chamber notes article 39(2)(b)(iii) of the Rome Statute (the ‘Statute’), which provides that ‘[t]he functions of the Pre-Trial Chamber shall be carried out either by three judges of the Pre-Trial Division or by a single judge of that division in accordance with the Statute and the Rules of Procedure and Evidence’.
5. According to article 57(2)(b) of the Statute, in all cases other than those listed in article 57(2)(a) of the Statute, ‘a single judge of the Pre-Trial Chamber may exercise the functions provided for in the Statute, unless otherwise provided for in the Rules of Procedure and Evidence or by a majority of the Pre-Trial Chamber’.
6. The Chamber further notes rule 7(1) of the Rules of Procedure and Evidence and regulation 47 of the Regulations of the Court, pursuant to which the designation of a single judge shall be based on objective criteria, including ‘seniority of age, criminal trial experience’ and ‘consideration of the issues involved and the circumstances of the proceedings before the Chamber, as well as the distribution of work within the Chamber and the proper management and efficiency in the handling of cases’.
7. In light of the criteria contained in the aforementioned provisions and, in particular, the need to ensure the proper management, expeditiousness and efficiency of the proceedings, the Chamber considers it appropriate to designate Judge Rosario

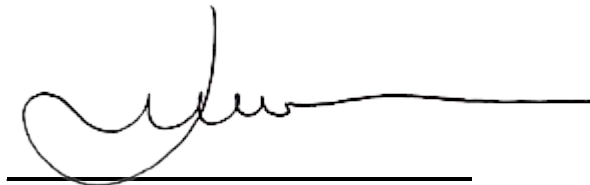

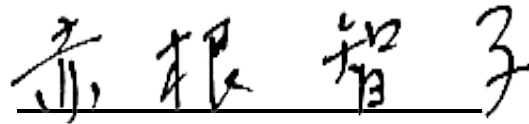
