I. Introduction

1. The Registry hereby informs the Pre-Trial Chamber II that Mr Dov Jacobs, a lawyer admitted to the List of Counsel of the International Criminal Court (“Court”), has been appointed as Associate Counsel for Mr Mahamat Said Abdel Kani (“Mr Said”) to represent him in proceedings before the Court. The appointment has been formalized by letter dated 7 April 2021.

II. Classification

2. The present submission and its Annex I and II are classified as public, whereas Annex III hereto is classified as confidential, in accordance with regulation 23*bis* of the Regulations of the Court (“RoC”) as it contains private contact details of Mr Jacobs.

III. Applicable Law

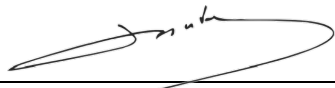

The following provisions are of particular relevance to the present submissions: articles 43 and 67(1)(d) of the Rome Statute, rules 21 and 22 of the Rules of Procedure and Evidence, regulations 23*bis*, 67 of the RoC, regulations 123(1) of the Regulations of the Registry and articles 5, 11 and 22(3) of the Code of Professional Conduct for counsel (“Code”).

IV. Submissions

4. On 7 April 2021, the Registry formalized the appointment of Associate Counsel.¹
