I. INTRODUCTION

1. Pursuant to Decision 1763 and extension granted *via* email, the Defence for Dominic Ongwen ('Defence') hereby notifies Trial Chamber IX, the Prosecution and Legal Representatives of the filing of the attestation forms for the following witnesses pursuant to Rule 68(2)(b) of the Rules of Procedure and Evidence.
2. The attestation forms are as follow:

 - c. Attestation forms for UGA-D26-0015-1858, witness statement of Ojara Charles, UGA-D26-P-0161 (Confidential Annex C);
 - d. Attestation forms for UGA-D26-0015-1861, witness statement of Onekalit Johnson, UGA-D26-P-0162 (Confidential Annex D); and
 - e. Attestation forms for UGA-D26-0015-1864, witness statement of Rwot Baptist Latim, UGA-D26-P-0163 (Confidential Annex E).
3. The Defence also files the practising certificates for the public notary used in Gulu, Uganda as Confidential Annex F.¹
4. The Defence files the annexes as confidential as they contain personal information of the witnesses not available to the public. Public redacted versions shall be filed shortly after the sentencing hearing is completed.

¹ The Defence notes that the practising certificates have the date 26 March 2021. This is the date the certificates were issued, but the public notary did not receive the certificates until after CoB on 31 March 2021 in Kampala, Uganda.
