I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication in relation to the disclosure of evidence relevant to the proceedings against Mahamat Said Adel Kani ("Mr SAID").

II. CONFIDENTIALITY

2. This communication and its annex are filed confidential pursuant to regulation 23*bis*(1) of the Regulations of the Court as they relate to the Pre-Trial Chamber II's ("Chamber") Order on disclosure and related matters of the same designation.¹

III. SUBMISSIONS

3. As part of the preparations for the relevant proceedings against Mr SAID, on 14 April 2021, the Prosecution disclosed "INCRIM Package 002" to the Defence and the Chamber. This package consists of 137 items which are documents, partial duplicates of documents and translations of statements cited in the Warrant of Arrest for Mahamat Said Abdel Kani.² The list of disclosed evidence is attached as Annex to this communication. All items are being disclosed with an additional dedicated field titled "Disclosure Notes (external)" to provide the relevant information under the legal classification INCRIM, PEXO, Rule 77 or Other in each disclosed item by indicating the corresponding page and paragraphs numbers for each relevant information when applicable pursuant to the Chamber's Order on disclosure and related matters.³
