I. Introduction

1. The Registry hereby informs the Pre-Trial Chamber II that Ms Katharina Lewis, a lawyer on the List of Counsel of the International Criminal Court ("Court"), has been appointed as Associate Counsel in the team of the Common Legal Representatives of Victims. The appointment has been formalized by letter dated 21 April 2021.

III. Applicable Law

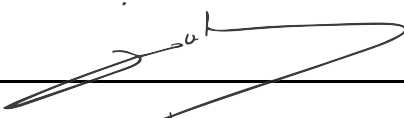

IV. Submission
