I. Introduction

1. The Registry hereby informs the Pre-Trial Chamber II that Ms Yasmine Chubin, a lawyer on the List of Counsel of the International Criminal Court (“Court”), has been appointed as Associate Counsel in the team of the joint Legal Representatives of Victims. The appointment has been formalized by letter dated 12 May 2021.

III. Applicable Law

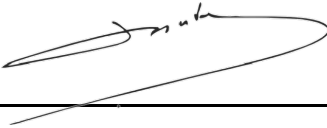
