1. In compliance with Trial Chamber II's Decision of 5 May 2021, the Trust Fund for Victims (the 'Trust Fund') has reviewed the case record and consulted with the Legal Representatives for Victims.

2. At this stage of the proceedings, the Trust Fund is seeking to maintain the confidentiality of the following information only: (i) TFV/Registry internal processes and Registry/Court internal security and health directions, including internal security reports, and references to Registry staff members' functions and specific work; (ii) specific details that could reveal the identity of victims; (iii) details about implementing partners or intermediaries; (iv) details about organizations that provided advice or were consulted on an informal basis; and (v) information about the ongoing implementation of the housing modality in order to ensure the security of the beneficiaries during implementation.

3. Details about the housing modality will be reclassified as public as soon as the implementation of this modality allows is.

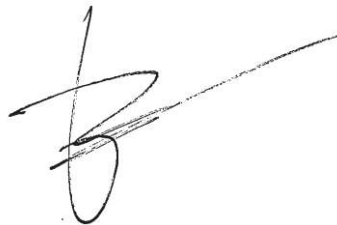
