## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as “Confidential” as they relate to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

3. On 7 July 2021, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Pre-Confirmation INCRIM Package 029” containing 69 items, “Pre-Confirmation INCRIM Package 030” containing 526 items, “Pre-Confirmation INCRIM Package 031” containing 498 items, “Pre-Confirmation INCRIM Package 032” containing 499 items, “Pre-Confirmation INCRIM Package 033” containing 498 items, “Pre-Confirmation INCRIM Package 034” containing 500 items, “Pre-Confirmation INCRIM Package 035” containing 367 items, “Pre-Confirmation Metadata Update package 003” containing 6 items (“Host Reference” update) and “Pre-Confirmation Metadata Update package 004” containing 2 items (“lesser redactions to the metadata” update).

4. The packages consist of witness materials relevant to OCRB, CEDAD and Chapeau elements of articles 7 and 8 of the Rome Statute, re-disclosure of documents whose metadata field “source” has been updated and of documents with lesser redactions to the metadata. The lists of disclosed evidence are attached as Annexes A - I to this communication.
