I. Transmission

1. In accordance with rule 13(1) of the Rules of Procedure and Evidence, the Registry hereby transmits the documents received by email on 9 July 2021, from the Permanent Mission of Venezuela to the Organisation for the Prohibition of Chemical Weapons, International Criminal Court and International Organisations and Courts based in the Kingdom of the Netherlands (“Permanent Mission”).

2. The received documents contain: 1) a Note Verbale from the Permanent Mission addressed to the Registry, dated 9 July 2021;¹ 2) a copy of a letter dated 8 July 2021 in Spanish from H.E. Mr Tarek William Saab, Attorney General of the Bolivarian Republic of Venezuela with a reference number DFGR-7876-2021 including the public “Communication of the Bolivarian Republic of Venezuela in execution of Decision of 14 June 2021 and Order of 2 July of Pre-Trial Chamber of the International Criminal Court, dated 8 July 2021”;² 3) the “Public redacted version of Request for judicial control submitted to the Pre-Trial Chamber I of the International Criminal Court by the Bolivarian Republic of Venezuela pursuant to Articles 15 and 21.3 of the Statute and Regulation 46.2 of the Regulations of the Court”³ and; 4) the “Public Response to the Prosecutions’ omnibus request in relation to its response to the request by the Bolivarian Republic of Venezuela and request for status conference”.⁴

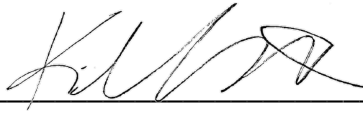
