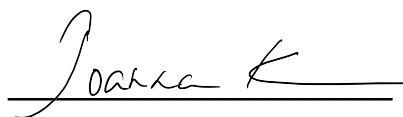
1. On 21 July 2021, the Presidency constituted Trial Chamber I, composed of Judges Reine Alapini-Gansou, Joanna Korner and Althea Violet Alexis-Windsor and referred to it the *Abd-Al-Rahman* case.¹
2. The judges of the Chamber have elected Judge Joanna Korner as Presiding Judge and Judge Reine Alapini-Gansou as Single Judge for the preparation of the trial, pursuant to Rule 132*bis* of the Rules of Procedure and Evidence and Regulation 13(2) of the Regulations of the Court.

FOR THESE REASONS, THE CHAMBER HEREBY

DECIDES that Judge Joanna Korner is elected as the Presiding Judge; and

DECIDES that Judge Reine Alapini-Gansou is elected as the Single Judge.
