I. INTRODUCTION

1. The Prosecution hereby notifies Trial Chamber I (“Chamber”) of the disclosure of evidence pursuant to rule 77 of the Rules of Procedure and Evidence (“Rules”).

II. CLASSIFICATION

2. This filing is classified as public with one confidential Annex. The Prosecution classifies Annex A as confidential since it contains a list of evidence that has been disclosed to the Defence and contains confidential information.

III. SUBMISSIONS

3. On 6 September 2021, the Prosecution disclosed to the Defence Pre-Trial Rule 77 package 37, consisting of two items (95 pages). The items in this package are two Reports received from the Netherlands Forensic Institute. These Reports contain a list of the extracted RAW files as well as their descriptions from the two mobile phones that were seized during Mr Abd-Al-Rahman’s surrender.
4. With respect to redactions, the Prosecution applied “standard” redactions as stipulated in the procedure for exceptions to disclosure that was adopted in this case by the Single Judge of Pre-Trial Chamber II on 17 August 2020.¹
