I. Introduction

1. The Registry hereby informs the Trial Chamber V that Ms Anta Guissé, a lawyer on the List of Counsel of the International Criminal Court (“Court”) has been appointed as Associate Counsel for Mr Alfred Yekatom to represent him in proceedings before the Court. III. Applicable Law

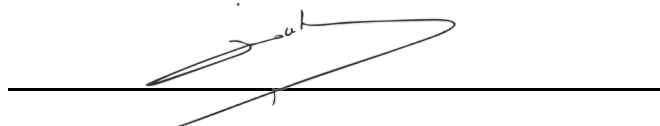

These submissions are made on the basis of articles 43 and 67(1)(d) of the Rome Statute, rules 21 and 22 of the Rules of Procedure and Evidence, regulations 23*bis* and 67 of the RoC, regulation 123 of the Regulations of the Registry and articles 11, 5 and 22(3) of the Code of Professional Conduct for counsel (“Code”).

IV. Submission

4. On 15 October 2021 the Registry formalised the appointment of Associate Counsel.¹
