I. INTRODUCTION

1. The Prosecution hereby notifies Trial Chamber I (“Chamber”) of the disclosure of evidence pursuant to articles 64(3)(c) and 67(1)(a) and (b) of the Rome Statute, and rules 76(3) and 77 of the Rules of Procedure and Evidence.

II. CLASSIFICATION

2. This filing is classified as public with one confidential annex, comprising the list of evidence disclosed to the Defence. This annex is classified as confidential since it contains confidential information.

III. SUBMISSIONS

3. On 14 and 19 January 2022, the Prosecution disclosed to the Defence three packages of evidence consisting of 10 items (94 pages):
 - Pre-Trial INCRIM package 100, containing 2 items (64 pages), including material related to two witnesses;¹
 - Pre-Trial INCRIM package 101, containing 2 items (4 pages), including material related to witness DAR-OTP-P-0843; and
 - Pre-Trial Rule 77 package 56, containing 6 items (26 pages), including material related to five witnesses.²
4. With respect to redactions, the Prosecution applied “standard” redactions to new items pursuant to the procedure for exceptions to disclosure adopted by the Single Judge of Pre-Trial Chamber II on 17 August 2020.³
