I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as "Confidential" as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 17 February 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Pre-Trial INCRIM package 049" containing 188 items and "Pre-Trial Rule 77 package 024" containing 42 items.

4. The disclosure of "Pre-Trial INCRIM package 049" consists of documents from Ministry of Public Security of CAR collected by the Prosecution and includes press articles, reports, lists, orders and instructions, which are relevant to the structure and functioning of the Ministry at the time relevant to the charges as well as for aspects of the chapeau elements of articles 7 and 8 of the Rome Statute.

5. The disclosure of "Pre-Trial Rule 77 package 024" consists of documents from Ministry of Public Security of CAR collected by the Prosecution and includes press articles, reports, lists, orders and instructions, which are deemed material to the preparation of the Defence.
