I. INTRODUCTION

1. The Prosecution hereby notifies Trial Chamber I (“Chamber”) of the disclosure of evidence pursuant to articles 64(3)(c) and 67(1)(a) and (b) of the Rome Statute, and rules 76(3) and 77 of the Rules of Procedure and Evidence.

II. CLASSIFICATION

2. This filing is classified as public with one confidential annex, comprising the list of evidence disclosed to the Defence. This annex is classified as confidential since it contains confidential information.

III. SUBMISSIONS

3. Between 4 and 7 March 2022, the Prosecution disclosed to the Defence four packages of evidence consisting of 143 items (556 pages):
 - Pre-Trial INCRIM package 106, containing 28 items (261 pages), including material related to five witnesses;¹
 - Pre-Trial Metadata Re-Issue package 22, containing 102 items (215 pages), with certain metadata fields re-issued;²
 - Pre-Trial Rule 77 package 66, containing 8 items (74 pages), including material related to witness DAR-OTP-P-0736; and
 - Pre-Trial Rule 77 package 67, containing 5 items (6 pages), including material related to four witnesses.³

4. With respect to redactions, the Prosecution applied “standard” redactions to new items pursuant to the procedure for exceptions to disclosure adopted by the Single Judge of Pre-Trial Chamber II on 17 August 2020.⁴
