I. Introduction

1. The Registry hereby informs the Pre-Trial Chamber II that Mr Maxime Jeoffroy Eli Mokom Gawaka (“Mr Mokom”) has appointed Mr Nicholas Kaufman as Counsel to represent him in the proceedings before the Court. The appointment has been confirmed by letter dated 16 March 2022, following the Counsel’s acceptance of the appointment.

II. Classification

2. The present submission and its Annex I, II and IV are classified as public, whereas Annex III hereto is classified as confidential, in accordance with regulation 23*bis* of the Regulations of the Court (“RoC”) as it contains private contact details of Mr Kaufman.

III. Applicable Law

3. The following provisions are of particular relevance to the present submissions: articles 43 and 67(1)(d) of the Rome Statute, rules 21 and 22 of the Rules of Procedure and Evidence, regulations 23*bis*, 67 of the RoC, regulations 123(1) of the Regulations of the Registry and articles 5, 11 and 22(3) of the Code of Professional Conduct for counsel (“Code”).

IV. Submissions

4. On 15 March 2022, Mr Mokom appointed Mr Kaufman as his Counsel.¹

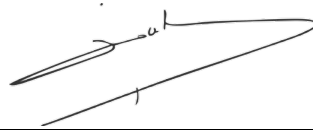
5. On the same day, Mr Kaufman accepted the mandate, as required by article 11 of the Code.²
