## I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as "Confidential" as they relate to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

3. On 17 March 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Pre-Trial INCRIM package 053" containing 15 items, "Pre-Trial INCRIM package 054" containing 2 items, "Pre-Trial INCRIM package 055" containing 51 items, "Pre-Trial INCRIM package 056" containing 23 items, "Pre-Trial INCRIM package 057" containing 53 items and "Pre-Trial INCRIM package 058" containing 1 item.

4. The disclosure of "Pre-Trial INCRIM package 053, 054, 055, 056 and 057" consists of email exchanges between alleged members of the Anti-Balaka collected by the Prosecution from the competent authorities of Ireland, which are relevant to aspects of the chapeau elements of article 8 of the Rome Statute that are classified as incriminatory evidence.

5. The disclosure of “Pre-Trial INCRIM package 058” consists of an investigator report related to the collection of documents from the Ministry of Public Security by the Prosecution, which is relevant to the chain of custody of the collection of documents from this Ministry.
