I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as “Confidential” as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 28 April 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Pre-Trial INCRIM package 064” containing 41 items, “Pre-Trial Rule 77 package 031” containing 114 items and “Pre-Trial Other package 009” containing 48 items.

4. The disclosure of “Pre-Trial INCRIM package 064” consists of materials which are relevant to the OCRB as well as aspects of the chapeau elements of article 7 and 8 of the Rome Statute that are classified as incriminatory evidence. This package includes witness documents, victim complaints, audio video material, photographs, a memorandum and reports.

5. The disclosure of “Pre-Trial Rule 77 package 031” consists of witness documents which are deemed material to the preparation of the Defence. This package contains documents related to witnesses P-1394, P-2475, P-0928, P-0958, P-1520, P-1522, P-1640, P-1932, P-2865, P-2021, P-2034, P-0307, P-0585, P-1265, P-1306, P-1311, P-1473, P-1510, P-1574, P-1603, P-0622.

6. The disclosure of “Pre-Trial Other package 009” consists of non-witness related evidence and includes press articles, reports, legislation, books, email communications, victim complaints, audio video material, transcripts and

translations. The Prosecution provides these items for the sake of completeness as part of its ongoing review of the evidence and under the legal classification of “Other” as they do not obviously include information material to the preparation of the Defence under rule 77 of the Rules of Procedure and Evidence.
