## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

3. On 13 June 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Pre-Trial INCRIM package 076” containing 88 items, “Pre-Trial INCRIM package 077” containing 41 items, “Pre-Trial INCRIM package 078” containing 9 items, “Pre-Trial Reclassification to INCRIM 007” containing 59 items and “Pre-Trial Metadata Update package 010” containing 1 item.

4. The disclosure of “Pre-Trial INCRIM package 076” consists of materials which are relevant to the OCRB as well as aspects of the chapeau elements of article 7 and 8 of the Rome Statute that are classified as incriminatory evidence. This package includes documents shown in the courtroom to witnesses P-0291, P-0884, P-0966, P-2232, P-2251, P-2328.

5. The disclosure of “Pre-Trial INCRIM package 077” consists of materials which are relevant to the OCRB as well as aspects of the chapeau elements of article 7 and 8 of the Rome Statute that are classified as incriminatory evidence. This package includes witness documents, photos and a report concerning the review and assessment of P-0349's seized phone handsets and associated devices (SIMS and SD cards) based on FSS extraction as well as related sources.

6. The disclosure of “Pre-Trial INCRIM package 078” consists of witnesses annexes as well as photos and a video show to INCRIM witnesses.
7. The disclosure of “Pre-Trial Reclassification to INCRIM 007” consist of documents which are now re-classified as INCRIM.
8. The disclosure of “Pre-Trial Metadata Update package 010” consist of a witness document re-disclosed with lesser redactions in metadata fields source identity and chain of custody.
