Explanatory Note

EXPLANATORY NOTE TO THE AMENDED VERSION OF ICC-01/14-01/18-793-Conf

The Defence of Mr. Alfred Yekatom has made the following modifications to “Mr. Yekatom’s Response to the Registry Observations on the Assessment of the Feasibility of using Video - Conferencing at the Detention Centre” (ICC-01/14-01/18-793-Conf) filed on 21 December 2020:

- In paragraph 1, the Defence replaced the word “respond” by “responds”.
- In paragraph 2, the Defence removed the word “family” after “The Defence contends that a” and before the word “videoconference”.
- In paragraph 2, the Defence added the word “members” after “videoconference call with family” and before “of 1 hour every 4 months”.
- In footnote 2 of paragraph 2, the Defence changed word “para” to “paras”.
- In paragraph 4, the Defence removed the color and the underlining after the name of the filing, on the word « videoconference » and at the end of the paragraph.
- The title A before paragraph 7 is changed from “A reasonable alternative to Mr. Yekatom’s inviolable right to receive family visit is required” to “A reasonable alternative to Mr. Yekatom’s right to receive family visit is required”.
- In footnote 5 of the paragraph 7, the Defence removed the color and the underlining at the end of the footnote.
- In paragraph 12, the Defence removed the color and the underlining after the word « videoconference », on the word « Country » and on the abbreviation « CO ».
- In paragraph 14, the Defence removed the color and the underlining on the quotations marks between the words “administrator rights”.
- In footnote 13 of the paragraph 17, the Defence added the hyperlink to the filing number and the changed the word “para” to “paras”.
- The numbering “C” is replacing the numbering “B” to the title “Current practice of both other International Tribunals and the Host State concerning videoconferencing” after paragraph 18.

- Footnote 18 in paragraph 19 is changed from “See <https://balkaninsight.com/2020/05/28/radovan-Karadzic-temporarily-allowed-video-calls-from-detention/>” to “BALKANINSIGHT, Radovan Karadzic Temporarily Allowed Video Calls From Detention, 28 May 2020”.
- The Defence replaced footnote 19 from “*Prosecution v. Karadžić*, Decision on request for review of registrar’s decision on video communications, RP D129-D128” to “*Prosecution v. Karadžić*, Decision on request for review of registrar’s decision on video communications, MICT-13-55-ES, 16 April 2020” and added the hyperlink to the decision.
- In footnote 27 of paragraph 24, the hyperlink is added to the filing number.
- In paragraph 26, the Defence removed the dash between the words « intensive » and « due ».
