Pursuant to the Chamber's order (*ICC-01/14-01/18-1420-Conf-Exp, para. 15 and page 9*) the Yekatom Defence ("Defence") hereby requests reclassification of its response to the Fifth Registry Report on the Implementation of the Restrictions on Contact for Mr Alfred Yekatom (*ICC-01/14-01/18-1366-Conf-Exp*) from "Confidential Ex Parte only available to the Yekatom Defence and the Registry" to "Confidential Ex Parte only available to the Yekatom Defence, the Registry and the Prosecution". This reclassification request relates only to the main filing and not to Annexes A and B.

The Defence however contends that the filing should still be maintained as Ex Parte in relation to the remaining parties as it contains information which relates to the private family life of Mr. Yekatom.
