The Single Judge takes note of the Yekatom Defence's reclassification request regarding filing ICC-01/14-01/18-1341-Conf (the 'Request').

Noting his obligations under Article 68 of the Statute, the Single Judge considers that this filing cannot be reclassified to public at this point. The Request is therefore rejected. He instructs the Yekatom Defence to file a redacted version of the filing, as instructed in decision ICC-01/14-01/18-1429, by 6 June 2022, and to ensure that any information identifying the protected witness is redacted therein.
