Dear Trial Chamber V,

The Defence for Patrice-Edouard Ngaïssona ("the Defence") kindly requests an extension of the page limit for the response to the "Prosecution's Application for Submission of Yahoo Email Evidence from the Bar Table Pursuant to Article 64(9)", ICC-01/14-01/18-1450 ("Bar Table Motion") pursuant to Regulation 37(2) of the Regulations of the Court. The Defence requests that the page limit for the cover filing be extended to a maximum of an additional 20 pages.

There are exceptional circumstances meriting this request. Notably, the cover filing to the Bar Table Motion consists of a total of 38 pages as a result of the Chamber granting the Prosecution's request for an additional 20 pages to file the Bar Table Motion by way of email on 23 July 2021 at 4:15pm. In order to fully respond to the detailed submissions contained in the cover filing and to make any additional submissions on over 300 items submitted in the Prosecution's annex, the Defence kindly requests that the same extension of additional page limit be applied to its response to the Bar Table Motion.

The Defence request for an extension of page limit is therefore proportionate to the nature and length of the Prosecution's Bar Table Motion.

For these reasons, the Defence kindly requests the Chamber to extend the page limit by 20 pages, for a maximum limit of 40 pages.
