Dear Trial Chamber V,

The Registry's Sixth Report is troubling. In particular, paragraph 15 thereof notes that the Accused has [REDACTED] in respect of the Chamber's longstanding contact restrictions order. Given the Chamber's prior determinations that the Accused has violated that order, the Report is alarming.

Although the Report asserts that the Accused's [REDACTED] In either case, it is concerning that the Registry is not in a position to say *affirmatively* whether the [REDACTED]

As such, the Prosecution requests the Chamber to inquire with the Registry urgently about the following matters:

- (1) has the Registry *verified* that [REDACTED]
- (2) how long has the Accused been receiving and/or had access to the [REDACTED]
- (3) has the Registry previously identified that it has no [REDACTED]
- (4) how, if at all, does the Registry intend to determine the [REDACTED]

This email is communicated on an *ex parte* basis because the pertinent information sought may have [REDACTED] As noted, we would very much appreciate the Chamber's urgent intervention given the potential witness security ramifications. Thank you.
