In relation to the 'Prosecution's Request to extend the contact restrictions imposed in the "Fifth Decision on Contact Restrictions" (ICC-01/14-01/22-131-Conf-Exp) (the 'Request') and the 'Fourth Registry Report on the Implementation of the Restrictions on Contact Ordered by Pre-Trial Chamber II' (ICC-01/14-01/22-132-Conf-Exp) (the 'Report'), please note that the Chamber:

- (i) instructs the Registry to submit a revised version of the Report containing a detailed assessment on: (a) the manner in which the contact restrictions were implemented; (b) information on whether Mr Mokom sought the addition of persons to his contact list and if so, whether any issues with regard to the [REDACTED] have been encountered; (c) whether there are any incidents or other matters of concern to report in respect of the contact restrictions; and (d) any other relevant matter, by no later than 23 January 2023; and
- (ii) noting that Mr Mokom has not yet selected permanent counsel, instructs Duty Counsel to provide a response to the Request and observations to the Report, on behalf of Mr Mokom, by no later than 26 January 2023 as specified in the 'Fifth Decision on Contact Restrictions' (ICC-01/14-01/22-106-Conf-Exp).
