The Chamber notes the submission of items by the parties (Email from the Prosecution dated 1 September 2021 at 18:00 and corresponding attachment; Email from the Defence dated 1 September 2021 at 15:53) following the testimony of P-0055.

The Chamber takes note of the parties' response to the submission of items by the other party (Email from the Prosecution dated 2 September 2021 at 15:10 and email from the Defence dated 6 September 2021 at 13:30) as well as the Prosecution's reply to the objections raised by the Defence (Email from the Prosecution dated 7 September 2021 at 12:06).

As a preliminary matter, the Chamber notes that the Prosecution has requested the submission of one additional item after the passing of the deadline under paragraph 34(ii) of the directions on the conduct of proceedings (Email from the Prosecution dated 3 September 2021 at 17:45). The additional item the Prosecution seeks to submit (MLI-OTP-0080-3990) is a list of corrections made to P-0055's reports submitted pursuant to Rule 68(3) of the Rules.

The Chamber considers that it is in the interest of justice, in particular the determination of the truth, to have the correct version of the aforesaid reports tendered into evidence and accordingly authorises the Prosecution to add MLI-OTP-0080-3990 to the list of items it seeks to submit through P-0055.

As regards the items identified by the parties, the Chamber is satisfied that the formalities under Rule 68(3) were met for all items whose introduction was authorised under that provision (*see* ICC-01/12-01/18-987-Conf) and that the remainder of the items were sufficiently used with the witness.

The Chamber notes that the objections of the Defence, in which it:

- (i) raises issues concerning the chain of custody of physical items and related inconsistencies ('Category A objections'); and
- (ii) raises a number of arguments in relation to the reports drafted by P-0055, in particular those relating to the chain of custody of associated evidence, the lapse of time between the mission and the preparation of the report, the evolution of the reports over time, lack of information in the reports concerning the individuals who were present while the collection of documents and P-0055's expertise and the methodology employed ('Category B objections').

In line with its previous rulings, the Chamber considers that such arguments do not prevent the submission of these items at this stage but will rather be considered as part of the holistic assessment of all evidence submitted when deciding on the guilt or innocence of the accused, having due regard to the submissions made by the parties.

For the aforementioned reasons, the Chamber authorises the submission of all items identified by the parties. The Registry is directed to proceed in accordance with paragraph 34(vi) of the Directions on the conduct of the proceedings (ICC-01/12-01/18-789-AnxA).

Please find below the Prosecution's response to the Defence's objections to the List of Material to be submitted regarding Witness P-0055.

The Prosecution reserves itself the right to further elaborate on these responses at the appropriate time.

#### **Category A Objections: Physical items**

##### *A. The chain of custody evidence*

The Defence's arguments relate to the weight to be afforded to the chain of custody evidence and therefore are immaterial to the question of whether the items concerned should be submitted at this stage. The Prosecution submits that in the present situation the initial link in the chain of custody proper began when the OTP collected the said items and took physical possession of them and not before. Contrary to the Defence's assertion, the chain of custody of the items has been clearly demonstrated in Court: Witness P-0055 identified the sealed bags containing documents that were collected at relevant locations during his mission with P-0057 (See ICC-01/12-01/18-T-123-CONF-ENG ET, p.13-14, l.20-15, p.19, l.5-25, p.25-26, l.3-15 and ICC-01/12-01/18-T-124-CONF-ENG ET, p.16, l.11-20). His testimony reflects what was already indicated in his reports including what further steps were taken to preserve the evidence for trial (See MLI-OTP-0041-0426; MLI-OTP-0039-0607, MLI-OTP-0029-1138 and MLI-OTP-0060-1920).

##### *(i) P-0963 and the chain of custody of custody evidence*

In regards to the Defence's assertion that Witness P-0963 should be called as a witness regarding the chain of custody: the Prosecution recalls that P-0963 simply wrote on the evidence bags and assisted in the mission (See ICC-01/12-01/18-T-123-CONF-ENG ET, p.19, l.19-25 and ICC-01/12-01/18-T-124-CONF-ENG ET, p.16, l.11-20). The appropriate witnesses for the chain of custody evidence are Witnesses P-0055 and P-0057 – who have already been heard by the Court and for whom the Defence had ample time to prepare for and did cross-examine at length. Issues regarding the date when items were collected were put to Witness P-0055 during his testimony and he clearly indicated that he was basing himself on his reports given the span of time that had passed since the mission had occurred (See ICC-01/12-01/18-T-124-CONF-ENG ET, p.14-17, l.7-4). It is unclear how calling P-0963 could help in clarifying this matter further. The metadata issue was already addressed in Court with Witness P-0055 (See ICC-01/12-01/18-T-124-CONF-ENG ET, p.19-27, l.3-12). In all, the Prosecution is by no means impugning the reliability or integrity of the metadata on the photographs. To the contrary, the Witness simply indicated that the metadata on the relevant

photographs may be inconsistent with the dates in the reports because of when they were accessed (See ICC-01/12-01/18-T-124-CONF-ENG ET, p.22-24, 1.4-5). This does not mean however that the metadata cannot be trusted. Finally, any relevant issue regarding P-0963 involvement in the chain of custody could have been put to either Witness P-0055 or P-0057 during their testimony.

### ***B. The authenticity of the collected items***

The authenticity of the collected items is supported amongst others by their very nature. They appear *prima facie* to be authentic records with all the relevant information that such documents would contain; they were collected from the BMS and the Hotel La Maison - locations that were used respectively as a Police station (and by the *Hesbah*) and a court house by the armed groups according to the evidence and the confirmation of their authenticity by Prosecution Witnesses [REDACTED]

[REDACTED]'s testimony is important in that it confirms that the items collected existed already during the occupation of Timbuktu. Further, there is no evidence on the record demonstrating that anyone planted or tampered with this evidence or had any motivation to do so. Any allegation to the contrary is entirely speculative.

#### ***(ii) The Hotel La Maison***

The Defence's assertion that "...the scene inside the Hotel La Maison between February and June 2013 was changed...", insofar as it implies that this was done purposely (according to the Prosecution's understanding) is based simply on the Defence's speculation regarding the evidence.

### ***Category B: Reports***

The Prosecution disputes the Defence's arguments. In sum, all of the points raised by the Defence relate to the weight to be afforded to the reports authored by Witness P-0055 and not to their submission. Further, there is no support for the Defence's third point that "...the content of the reports evolved over time, in a manner which suggests that they were moulded to fit the Prosecution's case." This serious and unfounded allegation was never put to either Witness P-0055

or P-0057 during their testimony as is required by Paragraph 51 of the Directions on the conduct of proceedings (ICC-01/12-01/18-AnxA).

**Subject:** RE: List of items of evidence to be submitted (Witness P-0055)

Dear Trial Chamber X,

Dear Colleagues,

Pursuant to paragraph 34(iii) of ICC-01/12-01/18-789-AnxA, the Defence provides its objections to the Prosecution's List of Material for Submission for Witness P-0055. The Defence submits that even if the Chamber accepts the submission of these items, these irregularities have bearing on the weight to be accorded to these items, and their alleged reliability as exhibits. All references throughout are to the confidential English edited version of the relevant transcript.

The Defence objects to the submission of Items 1-10, 11, 14, and 15-40.

#### **Category A Objections: Physical items**

Items 1-10 and 15-40 are a series of physical items allegedly collected by P-0055 (Items 1-10) which were then resealed in 2018 (Items 15-40).

The burden falls on the Prosecution to establish an intact chain of custody for evidentiary items under Regulation 22(1) of the [Regulations of the Office of the Prosecutor](#). Each individual item or page must be given to each individual item and this registration must happen at the earliest possible time and record all relevant circumstances of the collection and the chain of custody (Regulation 22(2)). As detailed below, this clearly did not happen in respect of the items collected at the Banque Banque Malienne de Solidarité and the Hotel La Maison; instead, items from different original locations were placed *en masse* in bags and only processed individually some years later.

Furthermore, the concept of chain of custody is not limited to the Prosecution's actions following the collection of items. As previous caselaw demonstrates, this includes obligations concerning the provenance of documents prior to the item(s) coming into the custody of the Prosecution. Failure to demonstrate the integrity of the locations at which items were found requires that additional care is taken and the documents in question may not be able to be relied upon. In *Prosecutor v. Dordević*, ICTY Trial Chamber II was considering a range of documents allegedly acquired during OTP document exploitation missions to Kosovo ([Decision](#), para 18). The Defence in that case objected to the admission of documents on the basis that, *inter alia*, a Prosecution witness had testified that many buildings in Kosovo from whence these documents came were unsecured making it possible for third parties to have access and hence for the documents to have been tampered with (para 19). The Chamber found that this uncertainty concerning the reliability of the documents meant that 'there is a need to be careful in ascertaining the authenticity of such documents' (para 21). In that case, certain items were consistent in formatting with other documents in evidence and bore indicia of authenticity (including stamps and consistent typesetting with other documents) (paras 22-24); in contrast, these items were a mixture of handwritten and typed documents which do not appear to be consistent in style or formatting to other documents of the same alleged provenance. The Defence notes also that in *Prosecutor v. Milutinović et al*, inconsistencies in chain of custody and provenance issues led to that Chamber discounting the evidence of a particular witness ([Judgment - Volume 3 of 4](#), para 545).

In these circumstances, in line with the care that should be taken in ascertaining the authenticity, it was incumbent on the Prosecution to, as was done in the *Dordević* case, investigate and document the chain of custody. To that point, members of the Office of the Prosecutor were present in Timbuktu between January to July 2013 and could have interviewed individuals concerning the integrity of the Banque Malienne de Solidarité and the Hotel La Maison, but failed to do so.

#### Integrity issues at the Banque Malienne de Solidarité and the Hotel La Maison

Over the course of his testimony, P-0055 conceded that he was not able to testify to the Banque Malienne de Solidarité and the Hotel La Maison being sealed and inaccessible from January to the dates of his entries on 19 and 20 June 2013, and therefore his testimony does not form a foundation for there being a clear and reliable chain of custody for the documents and items he allegedly found in these locations.

*Inter alia*, P-0055 was shown:

- J Defence Tab 7 – MLI-D28-0005-6979, which evidences a death of a jihadist in the premises of the BMS in between 31 March 2013 and 1 April 2013 (T-123, p. 60, line 10 to p. 61, line 15);
- J Defence Tab 8 – MLI-OTP-0001-7299, a photograph allegedly taken by Witness P-0007 in February 2013 which evidences that the door shown drawn together behind the metal gate of the BMS on his visit in June 2013 (see MLI-OTP-0039-0607 at 0612) was completely open at that time (T-124, p. 6, line 20 to p. 8, line 6). This evidences that individuals were present inside the BMS between February and June 2013 in order for these doors to be drawn together prior to P-0055's visit;
- J Defence Tab 24 – MLI-OTP-0012-2071, which is a video allegedly taken by P-0654 on 28 January 2013 which shows the windows of the BMS open and individuals removing things from it (T-124, p. 8, line 16 to p. 9, line 21);
- J Defence Tab 4 – MLI-D28-0005-6959 which is an article where a journalist describes removing all Arabic language documents that she found in buildings in Timbuktu prior to P-0055's arrival, including the building where the Islamic Court sat (T-124, p. 33, line 4 to p. 34, line 18); and
- J Defence Tab 3 – MLI-D28-0005-6941 which is an article where a journalist describes visiting the Hotel La Maison in June 2013 and seeing the chest of drawers in which P-0055 allegedly found the documents (T-124, p. 37, line 17 to p. 40, line 13).

Witness P-0055 stated that he did not ask any questions to the local authorities about whether anyone had accessed the ATM room of the BMS before his arrival (T-124, p. 8, lines 2-6) and later that he did not test to see whether the windows the BMS could open and that the sign shown in MLI-OTP-0012-2071 had been removed by the date of his visit (T-124, p. 9, lines 12-21).

As he concedes, P-0055 and his delegation did not video record their activities within these buildings or their discovery of any of the documents they allegedly found (T-123, p. 67, lines 2-11 regarding the BMS; T-124, p. 10, line 25 to p. 11, line 1 regarding the Hotel La Maison) and he did not take any photographs of any rooms in the BMS he accessed apart from the ATM room (T-124, p. 10, lines 5-14). This is significant because P-0055 testified that he did not find all the documents he found in the BMS within the ATM room (T-124, p. 37, lines 1-4), as evidenced by the evidence bags (e.g. each of MLI-OTP-0005-0009, MLI-OTP-0005-0011 and MLI-OTP-0005-0013 state that they contain documents found in the room to the left of the ATM room).

P-0055 testifies that he did not think there was a rug in the room of the Hotel La Maison with the chest of drawers (T-124, p. 29, lines 2-6; T-124, p. 40, lines 11-13) and indeed none is shown in his pictures (see MLI-OTP-0006-2086 and MLI-OTP-0006-2087), yet one is clearly visible in P-0007's photographs of the same chest of drawers in February 2013 (see Defence Tab 11 – MLI-OTP-0001-7604 shown to the witness at T-124, p. 28, lines 2-17) and is described in Defence Tab 3 – MLI-D28-0004-6941 (T-124, p. 37, line 17 to p. 40, line 13). Similarly, in Defence Tab 3 - MLI-D28-0004-6941, a journalist describes the presence of a short coil of rope in the room with the chest of drawers (T-124, p. 39, line 25 to p. 40, line 3). A short coil of rope is shown in a drawer of that chest of drawers in OTP Tab 231 – MLI-OTP-0006-2105 and the witness could not recall seeing any other pieces of rope elsewhere in the room (T-124, p. 40, line 14 to p. 41, line 8). This would suggest that the piece of rope seen by this journalist was either seen in this drawer (meaning that the journalist accessed the chest of drawers during his visit to the Hotel La Maison) or was

moved into this drawer subsequently to this journalist's visit and prior to P-0055's visit, which would have implications for the chain of custody of the items allegedly found in the chest of drawers either way.

This indicates that the scene inside the Hotel La Maison between February and June 2013 was changed, and specifically in the room in which P-0055 allegedly found these items which he conceded were not hidden (T-124, p. 35, line 10 to p. 36, line 15) and the drawers in which they were found were not locked and some were even open (T-124, p. 37, lines 10-16).

#### Inability of this witness to testify on the issues

P-0055 testified that he was not the member of his delegation who was responsible for obtaining authorisations and accesses to the relevant locations:

#### **ICC-01/12-01/18-T-123-CONF-ENG ET 31-08-2021, p. 59, line 15 to p. 60, line 9:**

15 A. [15:31:54] The governor afterwards -- I was not the person in charge of liaising  
16 with the senior officials. The government -- correction, the governor did not have  
17 the authority to give authorisation to a private establishment. That is what was told  
18 to us by the senior trial lawyer. The authorisation was obtained from the owner of  
19 the hotel.  
20 Q. [15:32:34] Who was the owner of the hotel?  
21 A. [15:32:39] I have no idea, Counsel.  
22 Q. [15:32:46] Did you obtain a copy of this authorisation?  
23 A. [15:32:52] Once again, I was not the person who took care of obtaining  
24 authorisations. It was my colleagues from the JCCD who took care of that, and we  
25 received an answer to the effect that the owner did authorise inspection of that hotel.

1 I even believe, and I'm not -- although I'm not quite -- entirely certain, but I believe he  
2 even gave the keys to someone who was still in Timbuktu. And thus, the  
3 establishment was opened up. There was no infraction.  
4 THE INTERPRETER: [15:33:43] Correction: There was no breaking in.  
5 MS TAYLOR: [15:33:47]  
6 Q. [15:33:47] Do you remember who he gave the keys to?  
7 A. [15:33:50] No, I have no memory of that. I don't know who he might have  
8 given the keys to. Once again, I stress I was not the person in charge of those  
9 aspects.

Over the course of his testimony, the witness testified that despite the fact that the evidence bags at Tabs 1-10 designate that these bags were 'Recovered by Dr Baccard', it was in fact P-0963 who filled out the descriptions on these bags:

#### **ICC-01/12-01/18-T-123-CONF-ENG ET 31-08-2021, p. 19, lines 17-20:**

17 Q. [12:29:31] Now, Mr Witness, these are indeed sealed bags containing objects  
18 seized during this mission and mentioned in the report; is that not the case?  
19 A. [12:29:53] Yes, the sealed evidence bags were prepared by participant B or  
20 investigator B. I can recognise his handwriting.

#### **ICC-01/12-01/18-T-124-CONF-ENG ET 01-09-2021, p. 16, lines 11-19:**

11 Q. [10:15:10] Now, Mr Witness, I'm trying to establish the chain of custody of these  
12 documents. Did you yourself collect these documents in the Hotel Maison?  
13 A. [10:15:24] Contrary to what you announced, Counsel, I didn't say that I  
14 remembered nothing. You didn't faithfully report my words. That's the first point.  
15 Secondly, I now have an enlargement on the screen of this evidentiary item, and I  
16 recognise the writing of my former colleague, B. And indeed, this is an evidence bag  
17 containing evidence of documents and items. However, I see "Fr upstairs" in the  
18 writing. But it was collected at Hotel La Maison the 19/6/2013 and the time that was  
19 indicated is 9 o'clock. That's the writing of my former colleague, B.

As the Chamber will be aware, Witness P-0963 was a witness for whom prior recorded testimony was accepted pursuant to Rule 68(2)(b). The Rule 68(2)(b) Application (ICC-01/12-01/18-1195-Conf), and the documents submitted pursuant to it, solely related to P-0963's collection and processing of items he received from P-0010 during a mission [REDACTED], and the associated chain of custody (Application, paras 2-5). Pursuant to the Application and its Annex, only five documents were submitted through P-0963:

- ) [REDACTED], a note dated 17 October 2019 signed by P-0963 detailing this mission;
- ) [REDACTED] a mission letter dated 25 September 2019 for this mission;
- ) three physical items being three envelopes collected from P-0010 (MLI-OTP-0002-0111, MLI-OTP-0002-0113 and MLI-OTP-0002-0122), all submitted into evidence through P-0010 and for MLI-OTP-0002-0111 and MLI-OTP-0002-0122, to be introduced into evidence through P-0188).

On the basis of the limited scope of the Application, the Defence did not oppose submission pursuant to Rule 68(2)(b) (ICC-01/12-01/18-1253-Conf). The Chamber granted the Application (ICC-01/12-01/18-1314-Conf, paras 11-13) and the Declaration pursuant to Rule 68(2)(b) was duly prepared and transmitted (ICC-01/12-01/18-1407-Conf and ICC-01/12-01/18-1407-Conf-Anx).

None of the issues discussed by P-0055 in his testimony concerning the chain of custody of documents relating to the June 2013 in Timbuktu were covered by the Rule 68(2)(b) Application.

As such, the Defence opposes the submission of the below items through P-0055 and submits that the appropriate course would be for P-0963 to testify pursuant to Rule 68(3) concerning these issues and for the Prosecution to seek to submit these physical items through P-0963 who presumably will be in a better position than P-0055 to testify concerning the chain of custody (noting, in particular, that P-0055 indicated a number of issues with his memory concerning the dates of when he visited the locations and what he saw there: *see, e.g.* T-124, p. 5, line 25 to p. 6, line 4; p. 6, lines 17-19; p. 12, lines 5-10; p. 22, lines 10-11; p. 40, lines 17-20). P-0963 would also be able to testify as to his role in drafting the third report with P-0055 and P-0057, which P-0055 was unable to testify to (T-124, p. 52, line 9 to p. 54, line 17).

#### Inconsistencies regarding the date and time of accesses between metadata

The evidence bags of items allegedly collected in the Banque Malienne de Solidarité and Hotel La Maison reflect the following dates and locations:

- ) Banque Malienne de Solidarité:
  - o Item 1 - MLI-OTP-0005-0002: 20 June 2013 at 07:30
  - o Item 2 - MLI-OTP-0005-0003: 20 June 2013 at 07:30
  - o Item 3 - MLI-OTP-0005-0009: 20 June 2013 at 10:14
  - o Item 4 - MLI-OTP-0005-0011: 20 June 2013 at 10:17
  - o Item 5 - MLI-OTP-0005-0013: 20 June 2013 at 10:27
  - o Item 8 - MLI-OTP-0005-0029: 20 June 2013 at 09:05
  - o Item 9 - MLI-OTP-0005-0030: 20 June 2013 at 09:11
  - o Item 10 - MLI-OTP-0005-0033: 20 June 2013 at 09:30
  - o (already submitted) – MLI-OTP-0005-0038: 20 June 2013 at 16:20
  - o (already submitted) – MLI-OTP-0005-0039: 20 June 2013 at 16:30
- ) Hotel La Maison
  - o (already submitted) – MLI-OTP-0005-0025: 19 June 2013 at 09:00

As was stated under cross-examination, there are a number of inconsistencies between the information on these evidence bags, the metadata of the images taken by P-0055 of the Banque Malienne de Solidarité and the Hotel La Maison (Items 43-63 and 93-259), and the metadata of the images taken by P-0057 of the locations.

Most notably, there is an overlap in time between when the metadata associated with P-0057's images places that witness at the Banque Malienne de Solidarité (20 June 2013 from 08:17 to 11:40), as does the information on evidence bags (Items 1-5 and 8-10) and the metadata associated with P-0055's images places that witness at the Hotel La Maison (20 June 2013 from 07:08 to 08:48). This overlap has implications for P-0055's testimony that they were physically together at these two locations when collecting evidence (*see* T-123, p. 52, lines 19-20; T-124, p. 10, lines 13-14; p. 20, lines 1-5; p. 23, line 11 to p. 26, line 25), that he only visited the Hotel La Maison on one day, 19

June 2013, and for the fact that there were photographs dated 20 June 2013 which shows items still in the chest of drawers at the Hotel La Maison after the witness said that they removed all items on 19 June 2013 (T-124, p. 20, line 6 to p. 22, line 23)

The Prosecution cannot claim that the photographs are sufficiently reliable to be admitted into evidence while at the same time, impugning the integrity of their electronic metadata. The Prosecution has adduced no evidence to suggest that the metadata dates are incorrect and has in fact supplied these dates in support of the admission of these items. The Defence should therefore be entitled to rely on the photograph dates provided by the Prosecution and corroborated by the metadata.

This clear statement by [REDACTED] particularly as it relates to both documents and amulets which P-0055 claims to have found at the Hotel La Maison, directly contradicts P-0055's accounts of events.

## Category B: Reports

Items 11 and 14 are reports authored or co-authored by Witness P-0055. These submissions should be read by reference also to MLI-OTP-0041-0426, MLI-OTP-0029-1138 and MLI-OTP-0060-1920 (which are also reports either authored or co-authored by Witness P-0055 already submitted through P-0057), as they have bearing on the weight to be accorded to all of them.

*First*, as noted above in respect of the physical items, there are a number of chain of custody issues and inconsistencies between different categories of evidence associated with these reports (*e.g.* the dates and times of collection differing between evidence bags, reports, and metadata of images).

*Second*, as P-0055 conceded the reports were not contemporaneously prepared. The reports span from approximately 2 years after and 6 years after the mission in June 2013, there are no contemporaneous notes of any of the members of the delegation in evidence (T-123, p. 53, line 19 to p. 54, line 3) and no inventory was taken (T-124, p. 64, lines 1-8). P-0055 testified that the delay to finalisation to the joint report was due to other responsibilities that he and the other authors had at the time and that he regrets the delay (T-124, p. 51, lines 19-25).

*Third*, the content of the reports evolved over time, in a manner which suggests that they were moulded to fit the Prosecution's case:

- ) none of the reports prior to MLI-OTP-0060-1920 (finalised circa June 2018) refer to the fact that the documents in MLI-OTP-0005-0025 were seized specifically from the chest of drawers in the Hotel La Maison, clearly a key detail for the purposes of chain of custody (T-124, p. 57, line 8 to p. 60, line 4 *cf* no mentions in each of MLI-OTP-0029-1138, MLI-OTP-0041-0426 and MLI-OTP-0056-0026 noting that MLI-OTP-0039-0607 exclusively concerned the Banque Malienne de Solidarité) – this detail was added upon instruction from the Senior Trial Attorney;
- ) the report finalised by P-0057 (the external expert) in 2016 (MLI-OTP-0041-0426) does not refer to the smell of urine (T-124, p. 50, lines 2-12) – this detail was added subsequently by P-0055 (the in-house Prosecution expert).

*Fourth*, there was a lack of information in the reports concerning which individuals were present during the alleged collection of the documents, no formal log of entries and exits was taken at the time and the witness testified that the members of the delegation other than P-0055 and P-0057 were not permanently with them while collecting evidence (T-123, p. 52, lines 16-20; T-124, p. 16, line 22 to p. 17, line 4; p. 19, line 21 to p. 20, line 5). The reports

also had a critical omission: none of these reports mentioned P-0055's role in the UNESCO mission which preceded the OTP mission of June 2013 and included a visit to the BMS (T-123, p. 46, line 11 to p. 48, line 18).

*Fifth*, the matters discussed within the reports were outside P-0055's scope of expertise. P-0055's background is in medicine as a pathologist (T-123, p. 30, lines 6-8); his forensic and expert roles at the ICTY were in respect of autopsies, exhumations, physical injuries and similar topics (T-123, p. 30, line 10 to p. 31, line 3) and he agreed that he did not have police training (T-123, p. 31, lines 8-11). Furthermore, during the relevant period, he held a role as the Head of the Forensic Science Section (T-123, p. 5, lines 7-9) and says that he and P-0590 were only put in charge of processing evidence bags because 'these were simple tasks that could be carried out by an administrative person' and absent volunteers they were the ones put in charge of this (T-124, p. 61, lines 19-22).

*Sixth*, the witness's testimony reveals major issues with the methodology applied: they did not check the drawers of the chest of drawers or the documents and items collected for fingerprints (T-124, p. 29, lines 7-16); they did not test the floor at the Banque Malienne de Solidarité for fluids in a forensic manner (i.e. by using Luminal to ascertain traces of blood) (T-123, p. 66, lines 10-11), they did not collect the mat or samples of it for analysis as concerns whether the alleged smell of urine came from humans or animals (T-123, p. 65, lines 17-21), and they did not conduct any forensic tests on the items taken (i.e the rope for DNA or other samples).

The Defence fails to explain how this article and the information therein is relevant to the chain of custody of items that were collected during Witness P-0055 and P-0057's mission. Further, the Defence has not demonstrated how this article is linked to Witness P-0055's credibility. Absent a clear logical explanation this article is not relevant to and has no probative value regarding the said chain of custody or the credibility of Witness P-0055 in this regard.

2. MLI-D28-0005-6979:

The Defence fails to explain how the event described in this article – dated 4 April 2013 - is linked to the chain of custody regarding the items that were collected during Witnesses P-0055 and P-0057's mission months later in June 2013. Absent a logical explanation this article is not relevant to and has no probative value regarding the said chain of custody.

3. MLI-OTP-0007-0211:

4. MLI-OTP-0007-0215:

The Defence fails to explain how the information in these reports is linked to Witness P-0055 and P-0102's credibility regarding their knowledge of these events. Absent a clear logical explanation these articles are not relevant to Witness P-0055 and Witness P-102's credibility.
