Dear All,

Please find below the updated schedule for Block 23 for the period 19 June – 14 July 2023.

First, please note that P-2389's testimony has been rescheduled to 27-28 June 2023. The Prosecution was unable to contact the witness in the days leading up to his previously scheduled testimony. Contact with P-2389 was only re-established yesterday. However, the resulting delay necessitates a postponement of P-2389's testimony dates due to logistical reasons.

Second, pursuant to Decision ICC-01/14-01/18-1907-Conf and the Chamber's 5 June 2023 e-mail sent at 13:57, the Prosecution has also scheduled P-2973 for testimony on 3-5 July 2023. Please note that efforts are still being made to schedule P-1576 into the last week of the upcoming Block as well. The Prosecution will update the schedule as soon as possible, should this possibility materialize.
