The Defence for Mr Ngaissona hereby requests a page-limit extension of an additional 15 pages, as well as for the submission of an 'argumentative' annex, pursuant to regulations 37(2) and 38 of the Regulations of the Court, regarding its upcoming response to the "Prosecution's Seventh Application for the Submission of Evidence from the Bar Table" (ICC-01/14-01/18-1874-Conf).

The requested extension is necessary to properly respond to the 32-page Application mentioned above, addressing a very large number of Facebook conversations (682 conversations and two related documents), involving ten separate Facebook accounts, which discuss and mention Mr Ngaissona and many other alleged Anti-Balaka leaders. The Defence notes that a similar request was granted by email to the Prosecution on 11 May 2023 at 16:28.

The Defence appreciates the Chamber's consideration and notes, for the Parties and Participants, that this request should be considered as 'confidential'.
