Dear Counsel, dear colleagues from the Registry,

The Chamber takes note of the emails on the submission of evidence following the examination of P-1576 by the Yekatom Defence and the Prosecution, as well as the Ngaissona Defence's objection to the submission of one item (*see emails below and attached*).

At the outset, the Chamber reiterates that items CAR-OTP-2075-0074, CAR-OTP-2061-4172, CAR-OTP-2061-4291 and CAR-OTP-2061-4293 have already been recognised as submitted, and that it therefore need not rule on them again (*see ICC-01/14-01/18-1907-Red*, para. 83).

The Chamber further recalls that it deferred its decision on the submission of 83 items out of the 377 [REDACTED] given that they had not been disclosed at the time Decision 1907 was issued (*see ICC-01/14-01/18-1907-Red*, para. 83). It further notes that the Yekatom Defence indicated that it would not provide any views on the items (*see email from the Yekatom Defence*, 20 June 2023, at 12:22), and that the Ngaissona Defence objects the submission of CAR-OTP-2061-4304 on the basis of it not being included in the Prosecution's List of Evidence.

In light of the above, and recalling the Presiding Judge's remarks during the hearing (*see ICC-01/14-01/18-T-239-CONF-ENG*, p. 6, line 18 to p. 7, line 25), the Chamber recognises as submitted all [REDACTED] which the witness provided in the context of his prior recorded testimony, with the exception of **CAR-OTP-2061-4304**.
