Dear Prosecution,

The Chamber has received the List of Material for P-1180, P-0510, and P-0358.

However, it has noted that the tabs for P-1180 and P-0358 are not numbered correctly. In particular, a number of items are registered as different versions of the same item, whereas in reality they are separate items. For example, for P-0358, items 4 to 4.16 are listed as different versions of the same item, even though each item is a different photograph. The same is true of tabs 5-5.3 and 7-7.1 in the List of Material for P-1180.

In relation to P-1180, the Chamber also notes that the e-binder includes a number of items that are not included in the List of Material and vice versa. In particular, the List of Material lists the witness preparation log and annex thereto (including the FRA translation), but they do not (yet) appear in the e-binder. Indeed, the items do not seem to be uploaded in e-court at all.

The Prosecution is therefore instructed to provide a corrected List of Material for the upcoming witnesses and to upload any missing items into e-court as soon as possible.

In addition, the Chamber instructs the Prosecution to update the List of Material for P-0622 to the new numbering format.
