Dear Prosecution,

Further to the Chamber's decision shortening the deadline for the Prosecution's response to the Defence's requests regarding P-2573's witness preparation sessions, the Chamber instructs the Prosecution to make the video of P-2573's witness preparation sessions available to the Chamber.

This is without prejudice to its eventual determination on the merits of the Defence's requests. It is only following the Prosecution's response to the Defence's requests that the Chamber will rule on whether P-2573's witness preparation video needs to be disclosed to the Defence, in accordance with paragraph 13 of the witness preparation protocol (#251-AnxA).

The Chamber finds it necessary that it receives the video at this stage as it recalls that there were significant technical challenges regarding the sharing of the video of P-1289's witness preparation and an expedited ruling will be required in relation to P-2573 in light of the anticipated start date of his testimony. Accordingly, in this instance, the Chamber considers it prudent to receive the video as soon as possible in order for it to make an informed decision on the Defence's requests.
