Dear colleagues in Trial Chamber VI,

Pursuant to the Chamber's decision (ICC-01/14-01/21-780-Conf) ordering the parties and the Registry, *inter alia*, to file public redacted versions of their filings, the Registry respectfully requests the reclassification to public without redactions of the following documents:
