 Dear Colleagues,

The Defence proposes to draft its R68(3) summary of evidence in a way that could be read in public session, without any identifying information. The summary would be much less precise (e.g. no mention of Witness D-35's rank and position; no mention of the role played by Witness D-35 in Mr Abd-Al-Rahman's recruitment in the CRF), but would have the benefit of offering minimum information to the public. The Chamber and the Parties have the full statement before them anyway. This summary could be read in public before we move in closed session for Witness D-35's appearance.

Please confirm that this approach is accepted. If not, I will prepare a much more detailed and precise summary of Witness D-35's evidence.
