Dear Registry,

Further to the Prosecution's request below, the Chamber hereby instructs the Registry to urgently file a report on the implementation of the Chamber's *Decision on the Prosecution's Request to Issue a Summons for P-0975* (Decision ICC-01/14-01/21-735-Conf). In this Decision, the Chamber determined it was necessary to issue a summons to establish: (i) whether P-0975 is still alive; (ii) if so, where he currently resides; and (iii) whether or not he is willing to testify.

In this report, please answer the above questions to the extent possible. Please also provide detailed information about your efforts to locate and/or communicate with P-0975 (either directly or through counsel) as well as any information you may have obtained about his whereabouts.

Considering the urgency of this matter, the Chamber instructs the Registry to file the report no later than tomorrow, 18 October 2024 at 14:00. The report must be notified to the parties, with appropriate redactions where necessary.

Dear Trial Chamber VI,

The Prosecution respectfully requests the disclosure of any report by the Registry, in a redacted form if necessary, confirming whether Witness P-0975's summons was successfully served on the witness or his lawyer, in compliance with Trial Chamber VI's directions in the Decision on the Prosecution's Request to Issue a Summons for P-0975 (Decision ICC-01/14-01/21-735-Conf).

In Decision ICC-01/14-01/21-735-Conf, issued on 2 April 2024, the Registry was directed by Trial Chamber VI, to among others, prepare and transmit P-0975's summons to appear and thereafter report on the implementation of the steps ordered by the Chamber.

To date the Prosecution has not been served any report by the Registry regarding the execution and, or service of the summons.

Disclosure of such a report from Registry is necessary to inform the Prosecution whether or not Witness P-0975 was found and will make himself available to the Court to testify in the SAID trial. The report will further enable the Prosecution to arrive at a conclusion whether or not it intends to present Witness P-0975's testimony in the SAID trial, and in which manner.

The timely disclosure of such a report will enable the Prosecution to meet the Chamber's deadline of 23 October 2024.
