We respectfully request a brief extension of the deadline, currently set for December 2, for the participants to indicate by email, any material they intend to use in the course of their closing statements (ICC-01/14-01/18-2600, para. 13).

After consultation with my colleagues—Prosecution counsel, Ngäissona counsel and Common Legal representative of Victims' counsels—all parties and participants agree that a short extension to December 4 would greatly aid in our preparations.

We therefore request that the Chamber consider granting this minor postponement, which would allow all parties and participants additional time to finalize effectively their closing statements with their visual aid and material.
