Dear colleagues,

The Single Judge recalls the ongoing reclassification exercise of the filings in the case file currently still not publicly available, pursuant to [email order dated 16 May 2024](#) and, more specifically, the [Order on reclassification of filings](#) issued by email on 1 November 2024, including *inter alia* the instruction to the Registry to consult the relevant authorities as to whether filings ICC-02/04-01/05-133-Conf-AnxI-AnxV and ICC-02/04-01/05-263-Conf-Anx2-Anx3 could be made public, with or without redactions, or if they should remain confidential.

The Single Judge notes the Registry's reports submitted via email on 5 and 14 March 2025 on an *ex parte* basis, indicating that:

- (i) The authorities of the Republic of Sudan agreed to the reclassification to public of Annexes I, II, III, IV and V of the "Supplementary Report of the Registrar on the Status of the Execution of the Warrants of Arrest in the Situation in Uganda" (ICC-02/04-01/05-133-Conf-AnxI-AnxV);
- (ii) The authorities of the Democratic Republic of the Congo agreed to the reclassification to public of Annex 3 of the "Submission by the Registrar on the Progress Made for the Execution of the Warrants of Arrest in the Case of Uganda" (ICC-02/04-01/05-263-Conf-Anx3).
- (iii) The authorities of Uganda indicated that they wished to maintain the confidentiality of Annex 2 of ICC-02/04-01/05-263.

The Single Judge, having taken note both of the nature of the information contained in document Annex 2 of ICC-02/04-01/05-263 and of the reasons submitted by the authorities of Uganda in support of the request that its confidentiality be maintained, considers that there is no overriding reason to reclassify the document as public at this stage.

Accordingly, the Single Judge orders that:

- (i) the current classification be maintained for ICC-02/04-01/05-263-Conf-Anx2;
- (ii) the following filings be reclassified as public:

ICC-02/04-01/05-133-Conf-AnxI to AnxV
ICC-02/04-01/05-263-Conf-Anx3.
