Dear Counsel, dear colleagues from the Registry,

The Single Judge takes note of the remaining contested redactions regarding transcripts T-138-CONF-ENG ET, T-139-CONF-ENG ET, T-140-CONF-ENG ET, and T-141-CONF-ENG ET, as transmitted to the Chamber per email on 23 May 2025 (see email from the Prosecution, 23 May 2025, at 14:58).

Having assessed these contested redactions, the Single Judge considers that it is necessary to maintain redactions to information that could potentially reveal the witness's identity, including regarding the meetings the witness may have attended. However, the Single Judge does not consider it justified to maintain redactions to information which is more general in nature. Accordingly, the Single Judge rules on the contested redactions as set out in the table below.

The Single Judge clarifies that he used the references included by the participants in their table sent per email, which are to the edited version of the transcripts. He directs the Registry to apply the redactions to the latest corrected version of each transcript.

In line with paragraph 72 of the Initial Directions, ICC-01/14-01/18-631, the Single Judge does not address the uncontested redactions.

The Registry is directed to proceed in accordance with paragraph 72 of the Initial Directions, ICC-01/14-01/18-631, for the English and French public lesser redacted versions of the transcripts.
