The LRV2 recall the Chamber's email instructions dated 14 April 2022 which indicated that "[s]hould exceptional circumstances require counsel to attend remotely, the Chamber will rule on requests on a case-by-case basis"; it is submitted that the current circumstances of the LRV2 warrants such an exception.

Indeed, given the limited resources available for the mission of the four external Counsels and the length of the hearing, the LRV2 agree that it is preferable that they attend remotely the hearing of the Delivery of the Judgment.
