Dear all,

The Yekatom Defence requests the application of limited post facto redaction to transcripts T-257 and T-258 related to witness CAR-D29-P-5014. As part of the review of transcripts of D29 witnesses it was noted that information in relation to D29-P-5014 should be redacted from the public transcripts.

Indeed, it is submitted that the information contained in the document attached, elicited in public session, are susceptible to identify the witness who benefits from protective measures (ICC-01/14-01/18-2296-Conf). Those information relates inter alia [REDACTED]. Redaction from the public domain of those information is of particular importance in light of the fact that [REDACTED] is not aware of her interaction with the Court (ICC-01/14-01/18-2293-Conf, para. 6).

The Defence is cognizant of the lateness the present request in light of the Chamber's previous order that "additional redactions to the corrected public version of a transcript would only be considered on an exceptional basis and should be requested within two working days of notification of the confidential corrected version" (see inter alia email from the Chamber dated 4 March 2025 at 10:56). The Defence apologizes for the oversight in the review of those transcripts.

It is however submitted that the request is necessary in light of the particularly identifying nature of the information for which the redactions are sought.
