Dear Counsel,

The Single Judge notes the ‘Kony Defence Request for Leave to Reply to the ‘Prosecution’s response to “Request for Reconsideration of the ‘Decision on the criteria for holding confirmation of charges proceedings in absentia’ (ICC-02/04-01/05-532)” (ICC-02/04-01/05-587)’ and the ‘Victims’ Response to the “Request for Reconsideration of the ‘Decision on the criteria for holding confirmation of charges proceedings in absentia’” (ICC-02/04-01/05-532) (ICC-02/04-01/05-588)’ (the ‘Defence Request for Leave to Reply’)’ (filing no. 590), as well as the ‘Prosecution’s response to the Defence’s request for leave to reply’ (filing no. 595) and the LRV’s support for the Prosecution position, as conveyed in the email below.

The Single Judge considers that the First, Second and Third Issues to which the Defence wishes to reply merely consist in arguments relied upon by either the Prosecution or the LRVs in support of their position vis-à-vis the pending Defence Reconsideration Request. As such, they do not consist in matters which could not have been reasonably anticipated; accordingly, a reply is neither warranted nor required for the Chamber’s adjudication of the Defence Reconsideration Request.

As regards the Fourth Issue, the Single Judge recalls its email decision of 24 April 2025, addressing the matter of the content and classification of the Annex to the Registry Report of 14 February 2025 and recounting the relevant background in detail, and finds that no further action is required in respect of that issue.

Accordingly, the Single Judge rejects the Defence Request for Leave to Reply.
