Dear Pre-Trial Chamber,

Pursuant to Regulation 23*bis*(3) of the Regulations of the Court, which provides that “[a] Chamber may also re-classify a document upon request by any other participant or on its own motion,” the Defence requests the reclassification of the public redacted version of filing ICC-01/04-02/05-602-Red, submitted yesterday afternoon, from public to confidential.

The Defence filed a public redacted version which was entirely in line with the Prosecution’s proposed redactions. However, following its distribution, the Prosecution identified further text which it considered should also be redacted. Following communication with the Prosecution, CMS temporarily restricted access to the filing.

In light of the above, the Defence asks the Chamber to reclassify the filing as confidential. A revised public redacted version will then be filed.
